QUALIFIED RIGGER CLASS

Moving large, heavy loads is crucial in today's construction industry. Overhead lifting is a special event and risk is created every time a load is lifted off the ground. Rigging and lifting operations affect virtually all construction trades, and each load that requires rigging has unique properties that can range from the simple to the complex. Recognizing the special risks involved in rigging and lifting operations, OSHA recently modified Subpart CC of Part 1926 Safety and Health Regulations for Construction (effective November 2010) to include the requirement that **employers must use "qualified riggers"** during hoisting activities for assembly and disassembly work. Additionally, qualified riggers are required whenever workers are within the fall zone and hooking, unhooking, or guiding a load, or doing the initial connection of a load to a component or structure.

OSHA defines a qualified rigger as a person that possesses a recognized degree, certificate or professional standing, or has extensive knowledge, training and experience and can successfully demonstrate the ability to solve problems related to rigging loads. This 8-hour course will provide important training to assist individuals in meeting the definition of a qualified rigger. Specific areas to be covered include:

- **Risk Management and the Basic Rigging Plan at the Load Hook** (Standards; Special Nature of Rigging; Basic Rigging Plan; OSHA)
- **Rigging Principals** (Operating Practices; Load Control Basics)
- **Loads on Rigging and the Rigging Triangle** (Weight of load; Finding the C.O.G.; C.O.G. & Sling Loading; The Rigging Triangle; The Load Multiplier; Other Rigging Triangle Factors)
- **Application of Hardware** (Material Properties; Environment; Rated Loads; Hoist Hook Applications; Shackle Applications; Links & Rings Applications; Turnbuckle Applications; Eye Bolt Applications; Wire Rope Termination)
- **Inspection of Rigging Hardware** (Frequency; Criteria; Terminations)
- **Application of Slings** (Wire Rope, Chain and Synthetic Sling Selection; Rated Load; Basic Hitches; Capacity Charts)
- **Inspection of Slings** (Inspection of Wire Rope, Chain and Synthetic Sling Selection)
